# Vomitoxin (DON):

Levels greater than 2.3ppm are subject to market discount or rejection.

## Falling Number:

**251 – 275** \$0.10; **226 – 250** \$0.25; **201 – 225** \$0.45; **U**nder **200** subject.

#### Dockage

All dockage will be deducted from gross weight beginning at .01% and at 0.1% increments

# Foreign Material:

Discounted \$0.02 for each 1.00% or fraction from 1.1% to 5.0%

## **Damaged Kernels:**

Damage over 4.0% subject to discount or rejection Heat damage over 0.2% will be rejected

# Smut Balls:

**1-4** \$0.10 per ball; **5-14** \$0.20; Above **15** balls reject

## Garlic (per 1000-gram sample):

**2-16** bulbs \$0.01 per bulb; **17-50** bulbs \$0.02 per bulb; over **50** bulbs reject

#### Infestation:

Two live insects injurious to grain or any combinations of dead or live injurious to grain totaling 5 will be rejected.

Insect Damaged Kernels (IDK) greater than 5 kernels/100 grams will be rejected.

#### Pesticides:

Wheat containing any residues of ethylene dibromide (EDB), ethylene dichloride (EDC), or carbon tetrachloride (CCl4) will be rejected upon detection.

# **Milling Quality:**

Off quality wheat such as: smutty, heat damage, garlicky, musty, sour, off odor, treated, sick, adulterated, and/or contaminated, etc. are subject to market discounts or rejection.

### **Blending:**

Wheat of other and/or contrasting classes blended into specified wheat is subject to rejection.

#### Oil:

We request that oil dust suppressant treatment not be used on wheat delivered to us.
