Wheat supplied must be free of residues of ethylene dibromide (EDB), ethylene dichloride (EDC), carbon tetrachloride (CC14). We request dust suppressant oils not be used on wheat supplied to us.

Seller guarantees that wheat delivered will pass pure food & drug inspection until unload. Until unloaded, title remains in name of seller.
